1. Get Set Event Hire may in assessing my/our application for credit or if the application is accepted and subsequently any payment becomes overdue obtain personal information and seek from a credit reporting agency or other credit provider information about my/our credit arrangement and I/we understand that this information may include my/our credit worthiness, credit history or credit capacity that the credit providers are allowed to give or receive pursuant to the Privacy Act 1993.
2. The applicant(s) must inform Get Set Event Hire in writing within seven (7) days of any change of his/her/their business details or corporate structure.
3. Get Set Event Hire reserves the absolute right to refuse or withdraw the applicant(s) credit facilities at any time in the event that the applicant is in breach of these terms and conditions.
4. All contracts between Get Set Event Hire and the Applicant shall be construed according to the laws of New Zealand.
5. Get Set Event Hire reserves the following rights in relation to any goods provided to the applicant by Get Set Event Hire, until all accounts owed by the applicant to Get Set Event Hire are fully paid:
  - (a) legal ownership of the goods;
  - (b) to enter the Applicant(s) premises or the premises of any associated company or agent where the goods are located without liability for trespass or any resulting damage and retake possession of the goods; and
  - (c) to keep or resell any goods repossessed pursuant to (b) above.
6. For the purpose of this clause "goods" include any equipment or plant owned by Get Set Event Hire.
7. I/we acknowledge that if the account is overdue, Get Set Event Hire at its discretion, reserves the right to refer the account to a Mercantile Agency for collection and I/we agree to be responsible to meet all reasonable costs and commissions incurred in employing the said mercantile agent to collect the overdue account.
8. I/we acknowledge and agree that the terms of payment are STRICTLY NETT CASH on the 20th of the month following hire or purchase. In the event the account becomes overdue, Get Set Event Hire reserves the right to charge interest at the rate of 2% per month from the date of hire and/or place your account on HOLD CREDIT as of the first day after the due date of invoices if the amounts remain outstanding.
9. Get Set Event Hire reserves the right to request that the applicant(s) update their credit application information every year and as a result some changes may be made to the details of your credit account. Refusal may also result in credit withdrawal.
10. Get Set Event Hire will provide a monthly statement. It is the applicant(s) responsibility to use this statement to reconcile their account and to notify the Accounts Department of Get Set Event Hire of any variances with the documents or contents within.
